Criteria for the Citizen of the Year Award

1. Citizen of the Year Award nominees will be nominated by the general public
2. Nominees must be a citizen of the town of Kindersley and area.
3. Nominee must be age twenty-one (21) or older
4. The achievement(s) on which the nomination is based must occur between February 1, 2016 and December 31, 2016 to be eligible.
5. Nominations should be based on excellence in one or more of the following areas:
 - Nominee is actively involved in community work and/or service club's/church groups outside of their place of employment or educational facility
 - Nominee has had an positive impact in the community
 - Nominee has demonstrated a personal commitment to the benefit of the community
 - Has performed an outstanding achievement or act of heroism

- The community has benefited from this person's involvement
- Has overcome significant personal adversity
- Has positive and inspiring personal attributes that serve to encourage others

The KBEX Awards Nomination Committee will only consider information that is included with the nomination. As part of your nomination, you are welcome to include testimonials, brochures and letters of reference, or any other documents that support the nomination. **The KBEX Awards Judging Committee will review all nominations and choose the award winners.** The jury is and will remain anonymous and its deliberations are completely confidential. The awards ceremony will be held on Friday November 03, 2017.
